Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

All financial companies need to share members' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their members' personal information; the reasons CVF Credit Union chooses to share; and whether you can limit this sharing.

#### WHAT WE DO:

How does CVF Credit Union protect my personal information?

To protect your personal information from unauthorized access and use we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We also provide you with educational materials related to identity theft to help safeguard your personal and account information.

# How does CVF Credit Union collect my personal information?

#### We collect your personal information, for example, when you:

- Open an account or Provide account information
- Apply for financing or Apply for a loan
- Make deposits or withdrawals from your account

We also collect your personal information from others, such as credit bureaus.

#### Why can't I limit all sharing?

#### Federal law gives you the right to limit only:

- Sharing for affiliates everyday business purposes information about your credit worthiness.
- Affiliates from using your information to market to you.
- Sharing for non-affiliates to market to you.

State law and individual companies may give you additional rights to limit sharing.

What happens when I limit sharing for an account I hold jointly with someone else?

Your choices will apply to everyone on the account.

#### **DEFINITIONS:**

#### **Affiliates**

Companies related by common ownership or control. They can be financial and nonfinancial companies.

• Catholic Vantage Insurance Agency

#### Non-affiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

• Non-affiliates that we share with can include government agencies, plastic card processors, financial statement publishers or printers, mail house, consumer reporting agencies, and check printers.

#### **Joint Marketing**

A formal agreement between nonaffiliated financial companies that together market financial products or service to you.
